"The Open Meetings Act", as amended, that a **Special** meeting of the above named **Commissioners' Court** will be held on the **6th day of October 2025, at 2:00 P.M.** in the County Courthouse, 3rd Floor, Franklin, Texas, at which time the following subjects will be discussed, to-wit:

3. PUBLIC COMMENT

- A. Maximum of 3 minutes and must have the completed Public Participation Form turned into the County Clerk's Office by 2pm the day before the meeting of the Court.

B. Discussion and possible action on any Sheriffs' Office & Jail related matters.
C. Discussion and possible action on Courthouse Security related matters and any other issues.
D. Discuss and take action on County Burn Ban.
E. Discuss and take action on approval to pay GrantWorks Invoice #04 in the amount of \$24,000.00 using ARPA Funds and check to be mailed.
F. Discuss and take action on Jail Administrator and Dispatch Supervisor salaries with the Sheriff's Office.
G. Discuss and take action on Bailiff salary with the Sheriff's Office.

- A. The Robertson County Commissioners' Court will reconvene in a public meeting to discuss and take action on related matters.

8. ADJOURN
