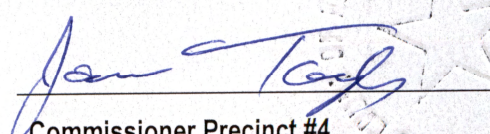

Commissioner Precinct #1

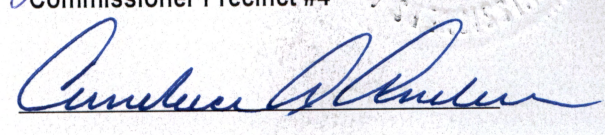

Commissioner Precinct #3
