"The Open Meetings Act", as amended, that a **Special** meeting of the above named **Commissioners' Court** will be held on the **21st day of August 2026 at 9:00 A.M.** in the Historic County Courthouse, 3rd Floor, Franklin, Texas, at which time the following subjects will be discussed, to-wit:

- A. Discuss any budget related matters or county business.
B. Discussion and possible action on any Sheriffs' Office & Jail related matters.
C. Discussion and possible action on Courthouse Security related matters and any other issues.
D. Discuss and take action on County Burn Ban.

6. CANDY ANDERSON, COUNTY AUDITOR

- A. Discuss and take action on approving budget adjustments, budget amendments, credit applications, lease agreements, or cell phone allowances.
B. Settlement of Accounts: Discussion, consideration and possible action to settle and pay all accounts against the county as per Texas Local Government Code Section 115.021.

7. EXECUTIVE SESSION

- A. 8. RECONVENE INTO REGULAR SESSION

- A. The Robertson County Commissioners' Court will reconvene in a public meeting to discuss and take action on related matters.

9. ADJOURN
