"The Open Meetings Act", as amended, that a **Special** meeting of the above named **Commissioners' Court** will be held on the **5th day of August 2020 at 2:00 P.M.** in the Historic County Courthouse, 3rd Floor, Franklin, Texas, at which time the following subjects will be discussed, to-wit:

- C. Discussion and possible action on Courthouse Security related matters and any other issues.
- D. Discussion and possible action on COVID-19 related matters and any other issues.
- E. Discussion and possible action on letter from Legal Services Texas Disability Rights regarding County website.
- F. Discuss and take action on County Burn Ban.

4. CANDY ANDERSON, COUNTY AUDITOR

- A. Discuss and take action on approving budget adjustments and/or amendments, credit applications and/or lease purchase agreements, and/or cell phone allowance agreements.
- B. Settlement of Accounts: Discussion, consideration and possible action to settle and pay all accounts against the county as per Texas Local Government Code Section 115.021.

6. RECONVENE INTO REGULAR SESSION

- A. The Robertson County Commissioners' Court will reconvene in a public meeting to discuss and take action on related matters.

7. ADJOURN
