PURPOSE: On behalf of Robertson County, the Robertson County Commissioners Court will conduct a Public Hearing and Voting Session to discuss and take possible action regarding an order concerning a proposed form of property tax abatement between the County and Tidwell Prairie LLC, pursuant to Chapter 312 of the Texas Tax Code.

Property Owner and Applicant for Tax Abatement: Tidwell Prairie LLC

Proposed Reinvestment Zone: Tidwell Prairie Reinvestment Zone #1

Anticipated Improvements:

Tidwell Prairie LLC anticipates constructing a 200-megawatt lithium-ion battery storage facility. Additional improvements for the Tidwell Prairie Project will include but are not limited to battery containers, large storage racks, HVAC system, electrical transmission cables, transformers, inverters, and any other equipment necessary to safely store, maintain, and transmit power to the ERCOT electrical grid.

Estimated Cost of the Improvements: The best estimate of capital investment of all such improvements subject to the requested tax abatement is \$140,000,000.

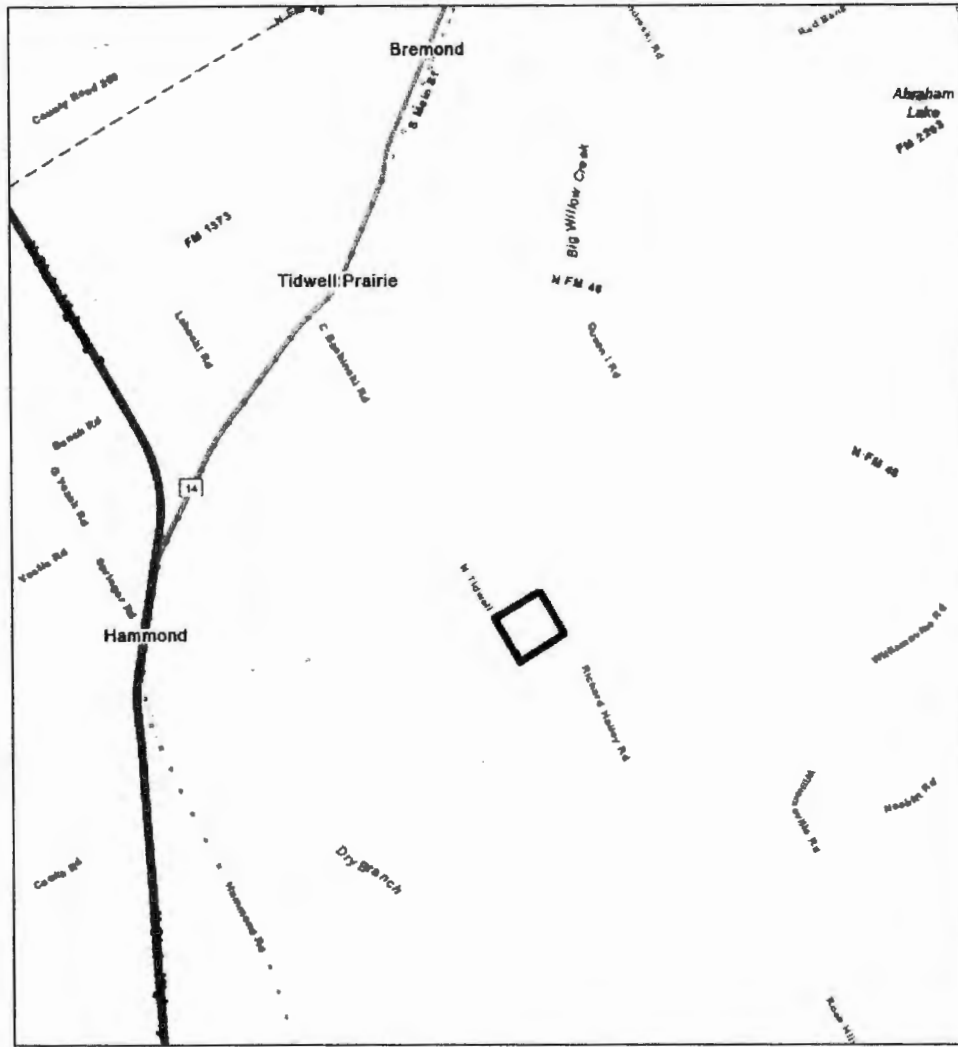

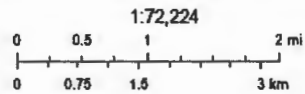
