By Order dated **DECEMBER 16, 2024** in Cause No. 8385, styled **IN THE ESTATE OF MARTIN LONGORIA, CLAUDIA LONGORIA** was appointed **TEMPORARY ADMINISTRATOR** of the estate of **MARTIN LONGORIA**, Deceased. The Order appointing Temporary Administrator specifies the period of the appointment, defines the specific powers given to the Temporary Administrator, and sets the amount of bond to be given by the Temporary Administrator.

Any heir or other interested person may request a hearing to contest the appointment of the Temporary Administrator **not later than the 15th day after the date this citation was issued**, being the same date that Letters of Temporary Administration were issued to the above-named Temporary Administrator.

In addition to filing a written answer with the clerk, you may be required to make initial disclosures to the other parties of this suit. These disclosures generally must be made no later than 30 days after you file your answer with the clerk, Find out more at the TexasLawHelp.org

If no contest is made within 15 days, the appointment will continue for the time specified in the Order appointing the Temporary Administrator, and the Court may make the appointment permanent.

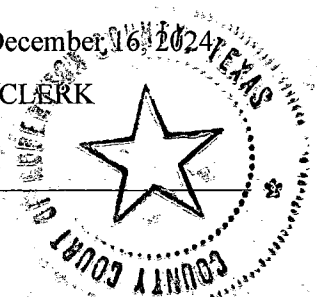
