AT THIS MEETING, THE COUNTY WILL CONSIDER AND TAKE APPROPRIATE ACTION ON AN ORDER CONCERNING A PROPOSED FORM OF PROPERTY TAX ABATEMENT AGREEMENT BETWEEN THE COUNTY AND BARTON BRANCH IA LLC PURSUANT TO THE COUNTY'S GUIDELINES AND CRITERIA UNDER THE PROPERTY REDEVELOPMENT AND TAX ABATEMENT ACT, CHAPTER 312 OF THE TEXAS TAX CODE.

**Anticipated Improvements:**

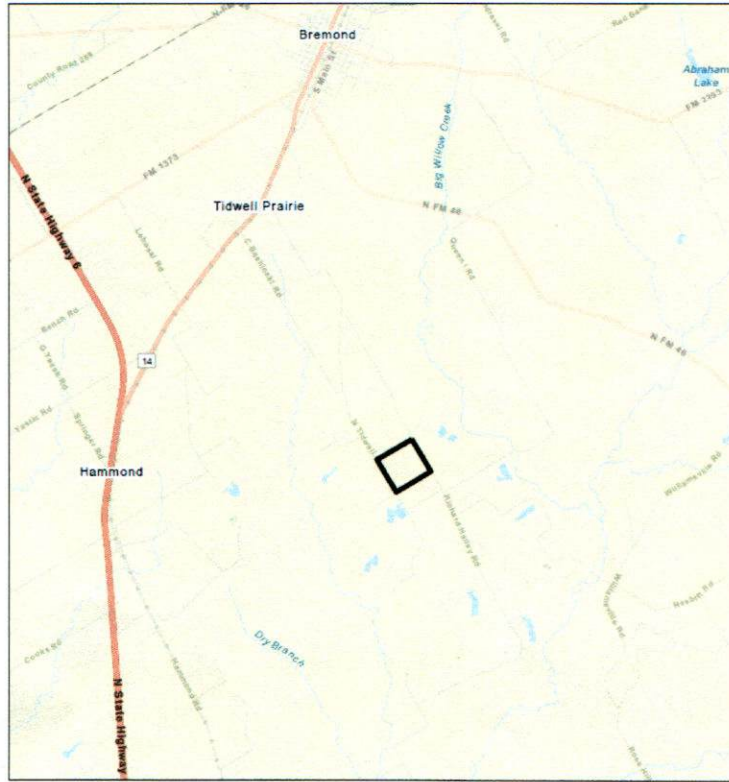
Barton Branch IA LLC anticipates constructing a 200-megawatt lithium-ion battery storage facility. Additional improvements for the project will include but are not limited to battery containers, large storage racks, HVAC system, electrical transmission cables, transformers, inverters, and any other equipment necessary to safely store, maintain, and transmit power to the ERCOT electrical grid.

**Estimated Cost of the Improvements:** The best estimate of capital investment of all such improvements subject to the requested tax abatement is \$140,000,000.

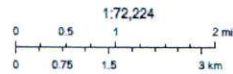
